NOW THIS AGREEMENT witnessed the following terms and conditions to be performed by both parties to the agreement.

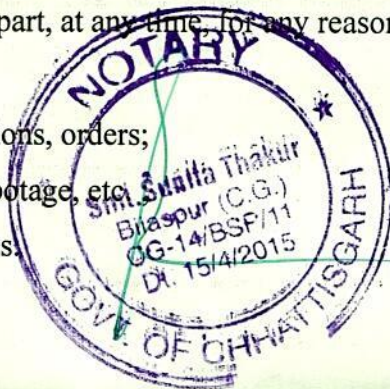
Party 1st

1. It is must to implement services within given duration.

 5. All commercials quoted in this proposal are exclusive of any in-country and withholding taxes. These will be applicable and payable by the customer.
 6. Taxes extra at actuals.
 7. The contract will have a validity of a minimum one-year. In the event of cancellation of the order, customer will have to give Airtel Enterprise Services a notice period of one quarter in advance and will have to pay for the reaming of the contract period.
