This Agreement is made on this 15th day of January, 2021 at Bilaspur (Chhattisgarh State)

BY AND BETWEEN

D.P. Vipra College having its office Old High Court Road, Bilaspur (CG) (herein after referred to as "Internet Leased Line Consumer with 50 MBPS" Through Dr. Smt. Anju Shukla its **Principal** to enter into and sign this Agreement for and on behalf of the Internet Leased Line Consumer, on the one Part, and

BHARTI AIRTEL LIMITED

Sarju Bagicha, Bilaspur (CG)

Herein after referred to as "Internet Leased Line Service Provider with 50 MBPS" through Mr. Sandeep Kamat, as a Ter. Sales the Second Part.

NOW THIS AGREEMENT witnessed the following terms and conditions to be performed by both parties to the agreement.

Party 1st

- 1. It is must to implement services within given duration.
- 2. Contract validity of minimum 1 year.
- 3. Institution has rights to discontinue the services after successful completion of agreement period.
- 4. Institution-will pay the billed amount and other charges if and only if when the invoice generated.

- 5. All commercials quoted in this proposal are exclusive of any in-country and withholding taxes. These will be applicable and payable by the customer.
- 6. Taxes extra at actuals.
- 7. The contract will have a validity of a minimum one-year. In the event of cancellation of the order, customer will have to give Airtel Enterprise Services a notice period of one quarter in advance and will have to pay for the reaming of the contract period.
